## **Old Business**

- > June 6, 2018 minutes were read and approved.
- Water Storage contracts was discussed. Thomas Wright motioned to accept the contract from Greg Dunnan and Ambassador Engineering as written, and accept the contract from Terrane Engineering with the exception from 10 times to 20 times on page 3-Frank Costello will need to initial contract. Ella O'Neill seconded the motion. Motion passed.
- Domestic rates were discussed. Thomas Wright motioned to raise the base rate on Exhibit 1A from \$24.94 + tax to \$27.43 + tax and excess water charge over 3000 gallons from \$3.20 + tax to \$3.52 + tax, and to change Exhibit 1 B –no change to the base rate of \$100.00 + tax, change the excess water charge over 3000 gallons from \$3.20 + tax to \$3.52 + tax effective August 1, 2018. Ella seconded the motion. The motion passed. Water bills are due by 5:00 pm on the 20<sup>th</sup> of the month. No grace period.
- > Irrigation rates were discussed. Charge by flow rate of well and acre feet of water. Rates will be different for each well. Vance Godwin motioned to accept the new rates effective August 1, 2018. Thomas Wright seconded the motion. The motion passed. Pay Pal signup will no longer be used. Elizabeth Fulghum will create an online signup for prepaid accounts or credit card users.
