 - 1. At well #5 sample tap has threads for use with a hose. Jordin would like to see another tap with no threads for sampling. There is an existing port on the pipe from the well where a threadless tap could go.

2. The concrete slab for the pump at well #4 is pitted and eroded, especially on the east side. He would like to see it patched so it is a smooth surface.
