Rates and Fees for Domestic and Irrigation Water

CHCID may change any of these costs or requirements as necessary to stay in compliance with EPA, ADEQ, MCED and CHCID requirements and to maintain a sufficient financial stability at any time and without notice.

Domestic Water, first 3000 gallons - \$27.43 + \$1.73 (6.3 % tax)	\$29.16
Domestic Water, each additional thousand gallons:	\$3.52
Residential Meter Account Connection/Transfer fee:	\$25.00
Security Deposit, Residential	\$200.00

Late payment fee:	\$7.50
Blue Door Tag fee:	\$25.00
Turn on Fee: after lock off for Nonpayment	\$45.00
Insufficient funds check fee:	\$30.00

Commercial Water, each additional thousand gallons:	\$3.52
Commercial Meter Account Connection/Transfer fee:	\$25.00
Security Deposit, Commercial:	\$500.00

Hydrant Meter Rental Cost

Hydrant Water, first 3000 gallons -\$100.00 + \$6.30 (6.3% tax)	\$106.30
Hydrant Water, each additional thousand gallons:	\$3.52
Security Deposit, Hydrant Meter:	\$1000.00
Connection fee:	\$25.00
Relocation fee:	\$25.00

Customer is responsible to attach a backflow assembly or air gap in water truck to prevent backflow condition into public water system.

Fire Protection and Connection Fees

1" Service	\$16,000.00
2" Service	\$24,000.00
4" Service	\$45,500.00

All Fire Protection Connections shall be provided with a CHCID approved shut off gate valve directly off of the water main and a Maricopa County Approved Back Flow Preventer.

Irrigation Water Rates

Property must be able to hold a minimum of 30 minutes of irrigation at 1600 GPM in order to receive irrigation. After 30-minute minimum purchase you may purchase in 15-minute increments.

Well # 2 South	\$24.40 per hour
Well #2 North, Well #3, Well #6 South	\$26.00 per hour
Well #7	\$25.20 per hour
Well #6 North	\$29.08 per hour
Customer Cancellation Fee	\$25.00/Occurrence
Late Sign-up Fee (1 time courtesy)	\$25.00/Occurrence

Irrigation Violations

Violations may include but are not limited to the following: water not contained within boundaries of property, opening or closing risers not at scheduled time, theft of water.

1st Violation	Warning letter
2 nd Violation:	Warning letter, \$25.00 fine
3 rd Violation:	Warning letter, \$50.00 fine.
4 th Violation	Warning letter, \$100.00 fine and suspension of irrigation privileges until customer appears before the CHCID Board of Directors to show that all violations have been corrected to the satisfaction of the CHCID Board.

All Penalties are assessed to a resident's irrigation account and are in addition to any water charges due to CHCID as a result of the violation(s) which will also be assessed to a resident's irrigation account. Irrigation violations do not reset annually, but do reset after 1 year if there are no more violations.

Water Violations: Warnings & Fines

Accidental Damage to the Domestic or Irrigation System, with current Blue Stake on file with the CHCID office

Fines of up to \$250.00 may be assessed and the violating party shall be held financially responsible for all costs for the legally safe return of the system to service.

Damage to the Domestic or Irrigation System, with no Blue Stake on file with the CHCID office

- a) For residential parties, there may be a fine up to \$500.00 plus the cost for the legally safe return of the system to service.
- b) For commercial parties, there may be a fine of up to \$2500.00 plus the cost for the legally safe return of the system to service.

Deliberate or Intentional Damage of any District property

This is a *Class 4 felony* according to the Arizona Revised Statutes 13-1602. Criminal charges will be filed against the responsible party, and all fines legal under the statutes will be collected.

Illegal or Unauthorized Main Line Connections

Theft of Domestic Water	Up to \$500.00 plus repair costs
Theft of Domestic Water for purposes other than household use	Up to \$5000.00 plus repair costs
Tampering with or damaging any installed meter assembly:	Up to \$500.00 plus repair costs
Unauthorized connection to District irrigation lines	Up to \$2500.00
